I. POLICY DISCUSSIONS

1. Dr. Jon Yopp discussed issues related to the acceptance of 3-year baccalaureate degrees from foreign institutions. Currently the Graduate School accepts these credentials from only a limited number of countries. There was a consensus among council members that we should expand this policy to all international applicants, recognizing that programs make the final decision on admissibility of applicants.
