I DISCUSSION ITEMS

- 1. Prof. Jackson opened the floor for discussion on the action taken on the Masters in Secondary STEM Education proposal. The original decision of council at the February 08, 2018 meeting was to approve the proposal contingent upon receiving an MOU approved and signed by both STEM and C&I representatives. Subsequently, Prof. Jackson was notified by UK Legal Counsel that a MOU could not be required for approval; Council members were so notified by e-mail. Given that the proposal *per se* was sound, and the MOU requirement now moot, the proposal was forwarded to Senate Council with significant concerns expressed regarding both the lack of agreement between C&I and STEM, and the marginal vote of approval for the proposal at the College level. Graduate Council members subsequently discussed and expressed concern over legal counsel becoming involved in the program approval process. This concern was conveyed to the Senate Council chair.
- 2. Prof. Jackson opened discussion on the Blue Ribbon Panel Report with the council members. Although detail was limited at the time, it appears the next step is for an implementation

team to be formed, and for recommendations to be presented to the Provost and Senate by the end of the spring semester.

3. Prof. Jackson sought input from council members on proposed Block Funding Metrics which included:

Selectivity/Yield URM enrollment Graduate student retention rates Time-to-degree

Concerns were expressed over the accuracy of the Selectivity/Yield data. Council members offered student productivity and analysis of allocated fund expenditures as additional potential items for consideration.
